LINCOLN HILLS ITALIAN CLUB WAIVER OF LIABILITY

READ THIS DOCUMENT CAREFULLY BEFORE SIGNING

The Lincoln Hills Italian Club (LHIC) requires all participants to assume all risks by signing this general release.

For and in consideration of being permitted to participate in the LHIC group activities (the "Activities"), I hereby voluntarily release, discharge, waive, and relinquish any and all claims or actions for damages for personal injury, death, or property damage which I have, or which may occur to me as a result of my participation in any Activities of the LHIC or for any other reason. This release is intended to discharge, in advance, the LHIC, its officers, members, or employees (collectively, the "Released Parties"). I further understand that serious accidents occasionally occur during Activities or while participants are driving or walking to areas where Activities will take place and that participants occasionally sustain serious personal injuries, death or property damage as a consequence thereof.

I understand this is a release of liability, which will prevent me or my heirs from filing suit or making any claims for damages in the event of injury or death to me. Additionally, in the event I file or my legal representative files a claim or lawsuit arising out of participation in any Activities of the LHIC, **I AGREE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS THE RELEASED PARTIES**, for any damages, attorneys' fees or costs arising out of such a claim or lawsuit. With the aforesaid fully understood, I nevertheless enter into this Agreement freely and voluntarily and agree that it is binding upon me and my heirs, assigns and legal representatives.

I am signing this waiver form with the full knowledge of California Civil Code Section 1542 which reads: "A general release does not extend to claims which the creditor does not know or suspect to exist in its favor at the time of executing the release, which, if known by him, must have materially affected his settlement with the debtor." The provisions of this statute are hereby waived.

By signing below, I am indicating my acceptance of this waiver and release and I am representing that I am in sufficiently good physical condition to participate in the programs and Activities of the LHIC.
